#### 1. VENDOR RESPONSIBILITIES

#### **Instruction To Bidders (ITB):**

## 1. Delivery of Bids: The Proposal is to be submitted as under:-

The Proposal indicating the quoted price in figures as well as in words along with essential literature / brochure if any, would be enclosed in an envelope.

## 2. Date and Time for Receipt of Bids:

## 4. Validity of Proposal.

The validity period of bids must be indicated and should invariably be not less than three months from the date of opening.

#### 5. Prices:

- a. The prices should be quoted FOR Islamabad basis. Price will be mentioned separately both in words and figures.
- b. The price validity period must be 03 months from the date of opening of Financial Proposal.

#### 6. Taxes:

All prevalent Govt. Taxes will be applicable.

## 7. Language of Bidding Document:

The bid must be prepared in English language. If supporting documents and printed literature furnished by the bidder with the bid are not in English language, they must be accompanied by English translation of the relevant passages.

## 8. One Bid per Bidder:

Each bidder shall submit only one bid either by himself, or as a partner in a joint venture. A bidder who submits or participates in more than one bid (other than alternatives pursuant) will be disqualified.

#### 9. Cost of Bidding:

The bidders shall bear all costs associated with the preparation and submission of their respective bids and the Purchaser will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

#### 10. Time Limits:

Bidder must provide the time limits about Designing / Layout / Mapping works of P3A office which should in no case be more than 21 days from the date of issuance of Work Order.

## 11. Terms of Payment:

Full payment will be made after completion of Designing / Layout / Mapping works.

## 12. Withdrawal of Proposal:

If the bidder withdraws its Proposal within validity period the competent authority may place such bidder under embargo for a period, which may be extended.

#### 13. Photocopies of relevant Documents:

Photocopies of following documents will be provided / attached with Proposal:-
