- i. Post-graduate degree in relevant fields (PhD preferred) from a local or foreign institution recognized by the Higher Education Commission (HEC); graduates from top-ranked global universities / institutions will be given preference
- ii. At least 10 years of professional work experience
- iii. Must be enrolled as a legal practitioner in Pakistan
- iv. Demonstrated experience of advising on legislative frameworks for public private partnerships as well as investment facilitation is a must
- v. Must have evidence of experience of assignments for advising federal and provincial governments on framing public private partnership regulatory regimes and drafting of rules and regulations
- vi. Strong background of working on transactional matters and projects, in Pakistan and/or internationally; evidence of experience on advising on public private projects
- vii. Must have strong understanding of P3A's mandate and functions

Terms of Reference

The expert will be expected to undertake the following tasks:

- a. review of P3A's legal and regulatory framework, identification of any gaps, and proposing modifications in line with public policy and international best practices;
- b. drafting of secondary legislation, including regulations and guidelines, under the P3A Act in order to fill any gaps in the existing framework;
- c. advising on pipeline-related and ongoing transactional and project-related matters;
- d. advising on organizational matters for purposes of establishing a highly effective regime for facilitating PPPs;
- e. advising on special initiatives under the P3A's mandate from time to time, including advisory mandate, as well as financing structures for mobilizing private capital;
- f. any other policy and legal task with respect to advising and representing the organization as may be assigned from time to time.
