Minimum Eligibility Criteria

- Post-graduate degree in Business Administration, Public Administration, Economics, Finance, Engineering, or a related field from a local or foreign institution recognized by the Higher Education Commission (HEC); graduates from top-ranked global universities/institutions will be given preference.
- Certifications in procurement or specialized training in PPPs, PEC, or FIDIC frameworks will be considered an advantage.
- At least 10 years of professional experience, with a minimum of 5 years in infrastructure procurement or PPPrelated procurement.
- Strong knowledge of PPRA rules, PEC regulations, and FIDIC standards.
- Proven track record in managing large-scale procurements, including drafting, evaluating, and negotiating contracts.
- Experience with national and international procurement regimes, including infrastructure project procurement.
- Deep understanding of PPP models, procurement laws, and compliance frameworks.
- Familiarity with financial and legal aspects of PPP transactions will be a plus.
- Proven track record of working with public/private sector organizations, including experience with federal-level entities in Pakistan or internationally.

Terms of Reference

The expert will be expected to undertake the following tasks:

- a. Develop and refine procurement frameworks and processes for PPP projects, ensuring alignment with the P3A Act and international standards.
- b. Provide expert advice on infrastructure procurements with a focus on PPPs, including drafting RFPs, bid evaluation processes, and contract finalization.
- c. Guide the procurement process for consultants, transaction advisors, and independent experts.
- d. Ensure compliance with procurement regulations, including PPRA rules and international procurement regimes.
- e. Develop recommendations for unsolicited proposals, concession agreements, and renegotiation principles.
- f. Analyze and optimize procurement workflows to improve efficiency and transparency.
- g. Provide technical input on procurement-related disputes or compliance matters.
- h. Remain up to date with global trends in procurement practices and integrate innovative solutions into the regulatory framework.
- i. Any other task related to procurement, as may be assigned from time to time.
