The Public Private Partnership Authority (“P3A”), a statutory autonomous entity of the Government of Pakistan set up pursuant to the Public Private Partnership Authority Act 2017, has issued a Request for Proposals (“RFP”) under a special programme (“Programme”) approved by the Federal Government and the Special Investment Facilitation Council (“SIFC”) for engagement of top-tier international consulting firms capable of providing world-class advisory services across various sectors.

The primary purpose of the RFP is to select and contract a consultancy firm that will offer expert advice and consulting support to ministries and key investment-related agencies of the Federal Government. The consulting firm will assist in driving major reformative work and investment projects, offering innovative solutions in line with global best practices to ensure successful outcomes. This engagement aims to facilitate the strategic objectives of enhancing economic development, growth and investment, while ensuring sustainability and efficient governance.

Pursuant to the framework approved by the Federal Government and the SIFC for the Programme for hiring top-tier consulting firms (“Government Approved Framework”), for each consulting assignment, a category of firms will be shortlisted as per the methodology specified in the Government Approved Framework.
